b) Candidates should ensure that they have their scanned recent colour passport size photograph (JPG/JPEG /PNG format of size 20-60 KB) and

signature (JPG/JPEG/PNG format of size 10-30 KB) separately.

(c) The online application should be uploaded with the photograph and signature of the candidate with complete information.

d) A valid e-mail id and Mobile Number are mandatory for registration and e-mail id should be kept active till the declaration of results

e) All the particulars mentioned in the online application including name of the candidate, paper applied, communal category, date of birth, address and all other fields will be considered as final.
